17. Planning Commission/Zoning Hearing Board Meeting pay will be \$30.00 for planning commission members and \$35.00 for zoning hearing board. Edwin Bishop to be voted on a new 6 yr. term on the Planning Commission, Clark Landsiedel for a new 6-year term on the Zoning Hearing Board.
18. Lot improvement subdivision \$150.00 plus review fee.
19. Continuing the policy and rate to pay officials attending sessions to enhance, expand, or improve performance of their duties with the approval of the supervisors at a rate of \$20.00 for 2-hour session and/or hourly supervisor rate or road worker, secretary, zoning officer current rate. \$.58 1/2 cents mileage rate.
20. Supervisors/Secretary to attend the State /and or National Convention and to be paid for doing so at their current rate.
21. One township meeting/per month and one work session/per month regular meetings will be on the second Thursday of every month and work sessions will be held on a as needed basis. Thursday monthly meetings will have a (7:00-9:00 p.m. maximum time) All meetings that are scheduled for holidays are to take place on the Friday following.
22. Citizen's participation be limited to 3 minutes per subject discussed during township meetings.
23. First National Bank be the depository bank and PLGIT be our secondary bank
24. Temporary Road Worker will be paid at the supervisor's discretion with no benefits.
25. 12 paid holidays be given after 90 days of employment along with healthcare being the same, after 1year of employment- 1 week of vacation be given, after 4 years employment 2 weeks vac after 8 years of employment 3 weeks. After 20 years of employment 4 weeks of vacation will be given: 5 sick days will be given per year which can be accumulated up to 20 days. Employee will be paid if not taken at the end of the year (doctors note needed after 3 days of being sick) Funeral for immediate family members 3 days with pay and 1 day for other.
